Legacy Giving:

IcFEM Mission firmly believes that family and dependants should have priority when planning the distribution of possessions in a Will. After making provision for your family, you may have resources you would like to use to help others in need.

Since 1996 IcFEM Mission has sought to transform communities and build rural people's self esteem so that they become spiritually and practically self-supporting. We do this as a practical expression of the love of God, bringing substance to their hope and a brighter future.

Immediate practical help is tailored to the needs at the time, followed by longer-term provision of medical care, homes, education and job creation, working closely with local churches and agencies. Those who benefit are always very appreciative of the kindness of donors who wish to help those less fortunate.

A relatively small amount of finance can make a big difference to those in need in poorer countries, giving them immediate relief, as well as the chance to regain their independence and the self-respect that comes from self-sufficiency.

A legacy or donation to the work of IcFEM Mission may be restricted to a particular department or project if you wish. However, the best way you can help support and preserve our ministry is to make your gift unrestricted. It may then be used appropriately for any project requiring funding at the time the legacy is received as needs can arise or change very rapidly and IcFEM endeavours to respond equally rapidly.

How to leave a gift to IcFEM Mission in your Will:

Your Will plays a crucial role in continuing to help the people closest to you. It could also provide you with an opportunity to continue supporting IcFEM's work; building a better future for the people they seek to serve in Kenya.

If you are unsure how best to help IcFEM leaving a share of your estate may be the simplest option as the value of your gift will remain unaffected by inflation. This is called a residuary legacy and is a gift made from the residue of your estate, once all your family and friends have been provided for.

When you visit your solicitor, they may find the following wording useful:
